**TERMS AND CONDITIONS**

---

1. To be eligible for a rebate, I understand that I must be a Westborough Water District customer with an active service account and that I am only eligible to receive rebates for energy-efficient washing machine designed to reduce water consumption. The model must be on the ENERGY STAR models. To shop for energy-efficient clothes washers and check for rebate eligibility, go to [https://www.energystar.gov/products/appliances/clothes\\_washers](https://www.energystar.gov/products/appliances/clothes_washers). **Limit:** One rebate per household within a five-year period.
2. I understand the rebate offer is limited to residential customers for residential use. The energy efficient washing machine must be installed in a residential dwelling within district service area. The dwelling unit must be fully constructed and occupied with a minimum billing history of 12 months. **Only existing homes – no new construction.**
3. I understand the rebate program is for washing machine purchases made starting January 1, 2017, and any purchases made prior to this date do not qualify for a rebate. Applications are accepted on first – come, first served basis. The program may be modified or terminated without prior notice. Applications must be submitted within 60 days of purchase, and product must be installed and operational before you submit the application.
4. I understand the washing machine must be new and installed. Resale units, units leased, rebuilt, rented, purchased, won as a prize, or new parts installed in existing units do not qualify.
5. The rebate check for qualifying product(s) will be mailed 6 to 8 weeks after receiving a completed application including all required documentation (proof of purchase).
6. I agree that the selection, purchase, installation and ownership/maintenance of the products and measures listed in this application are my sole responsibility and that my supplier or installer of these products, and measures is not an agent or representative of Westborough Water District.
